### Strawberry Hill Estates Homeowners Association Business Meeting Minutes – 2015

The Annual Meeting of the Strawberry Hill Estates Homeowners Association was attempted to be held on Thursday April 30, 2015 at 8:00 p.m. at the Hamburg Township Senior Center.

Only eleven homeowners were present, and thus there was not the required quorum to hold the Annual Meeting. It was decided by those in attendance that we would discuss the 2014 minutes and the finances/Treasurer's report and any other business issues or concerns of the neighborhood. These Minutes are the record of that Business Meeting.

- The Secretary presented the 2014 Minutes to those present, and there were no comments or revisions requested.
- The Treasurer presented his report and consequent explanations. It was noted as in previous years that the report is incomplete and that it is a partial statement of cash flow only, not an Income Statement or other standard financial statement. In addition, the required notes to the financial statements were presented verbally by the Treasurer as in previous years, and those notes should be in writing. The Secretary recorded some of these notes to the financial statements on the handout that she received at the meeting as the Treasurer spoke, e.g.,
  - The Liability Insurance expense stated is actually half the amount stated since it is split with the Bluffs; we have yet to receive that income;
  - o The Liability insurance for the Directors is for two years, 2014 and 2015;
  - There are a number of homeowners behind in their dues, and one owes approximately \$700. (No receivables were listed in the report.)
  - Other issues such as lake assessment, website expense, taxes on lots, etc., need to be represented accurately in the document in a proper financial format, and any explanations need to be in writing.
- Other items discussed
  - Mary McLaughlin, in her role on the Joint Parks Committee presented the proposed budget, attached, for the work that needs to be done this year. There was general support and no comment. She noted lake weeds are a major problem.
  - o It appears that a lakeside house near the park is depositing leaves and other yard refuse on the park property under the basketball court. There was concern that the piece of property is actually not the park's but the DNR's or other. Steps to address the problem were discussed but not finalized.
  - Some neighborhood people want to organize a garage sale in the neighborhood.
     The Board did not volunteer to organize this activity.
  - o Amy Brehm, from the Bluffs, recently passed away after a lengthy illness.
- Directors: Although there was not a quorum to vote in new Directors, the current Board was asked if they would be willing to serve until the next Annual Meeting, and the each agreed to do so. They are: Dave Walmroth, President; Mary McLaughlin Vice President and Secretary; Craig Mestach, Treasurer.
