## **NEW BUSINESS**

- **Monthly Treasurers Report:** May 8 and June 8, 2021 (see next page). Reviewed and approved by the Board at this meeting.
- **Dues Increase for SHEHA:** The SHEHA Board scheduled a Strawberry Hill Estates "Special Meeting" to discuss a dues increase for Thursday, July 29<sup>th</sup> at 7pm at the Park. A postal mailing must be sent this week to comply with the By-Laws' 14 days advance notice requirement.
- **Approve JAC 2021 budget:** Unanimous approval of the *Annual Maintenance* items by the Board, and encouragement for the Boards to agree on funding and managing the listed *Major Improvements*. (Should a Joint Bluffs/Estates Board meeting convene to discuss major projects?) Corinne to send notice to Joe Ouillette, JAC President and Jim Dwyer, Bluffs President.
- **Approve 2021 "Pig Out" Pig Roast funding:** Unanimous approval of the event. If ticket revenues are insufficient, the Estates Board approved funding the financial loss. If ticket revenues produce a profit, additional funds to be retained and earmarked by the JAC for next year's event. Residents who purchase tickets with a check should make payment to the JAC, which will act as a clearing house for Pig Roast finances. Corinne is trying to arrange a discussion with Jim Dwyer, Bluffs President to ensure alignment of Estates and Bluffs approaches to the Pig Roast.
